On a motion by Dahlgren, seconded by Evans, the Village Board of Trustees and Village Attorney, Jeff Cox, adjourned into executive session at 8:21 PM to discuss the Interlocal Merger/Inclusion Agreement between the Village of Bertrand and Rural Fire Protection District. Voting Aye, Dahlgren, Evans, Schroeder, Wilcox. On a motion by Dahlgren, seconded by Schroeder, the Village Board of Trustees and the Village Attorney returned from executive session and returned to the regular meeting at 8:43 PM. Voting Aye, Dahlgren, Evans, Wilcox, Schroeder. On a motion by Schroeder, seconded by Evans, the Board tabled any further action until the March meeting. Voting Aye, Schroeder, Evans, Dahlgren, Wilcox. On a motion by Dahlgren, seconded by Schroeder, the Lease agreement with Hi-Line Golf Association was approved for another twenty (20) years. The Lease agreement will automatically be renewed every twenty years. Voting Aye, Dahlgren, Schroeder, Evans, Wilcox.

On a motion by Dahlgren, seconded by Evans, the Building Permit request from Daniel Schwarz to construct a 24'x30' addition to the house at 602 Melbourne was approved. Voting Aye, Dahlgren, Evans, Schroeder, Wilcox.

On a motion by Dahlgren, seconded by Schroeder, the Building Permit request from David Root to construct a privacy fence and pergola with some concrete at 319 Keopple was approved. Voting Aye, Dahlgren, Schroeder, Wilcox, Evans.

Village Clerk Carol Johnston informed the Board that the property at 619 Minor Avenue has been sold. That is where the Village has the recycling center. The Board will discuss with Village Superintendent Matt Gregg on what he thinks the Village should do with the recycling center and find out what our options are. The Village can rent the property but no price has been established at this time.

Neal Niedfeldt with Southern Power contacted the Village Office and asked the Board to approve the sending of a letter to Senator Dan Hughes to show opposition to two (2) bills going before the Legislature on February 16, 2017. LB657, Retail Electricity Transparency Act and LB660, Nebraska Retail Electricity Choice Act. Village Attorney, Jeff Cox, explained both Bills to the Board and approval was given to send a letter to Senator Hughes.

On a motion by Schroeder, seconded by Dahlgren, the meeting adjourned at 9:27 PM. Voting Aye, Schroeder, Dahlgren, Evans, Wilcox.
