On a motion by Evans, seconded by Schroeder, a shift differential setting an hourly rate rather than a shift rate for a weekend shift bonus was approved. Voting Aye, Evans, Schroeder, Dahlgren, Weber, Wilcox.

On a motion by Weber, seconded Dahlgren, a private room rate increase of 7.5% was approved. Voting Aye, Weber, Dahlgren Evans, Schroeder, Wilcox.

Guest, Brad Slaughter, Ameritas Investment Corp., presented the Board funding options for a swimming pool bond. The presentation provided a 20 year amortization for projects of \$2 million and \$2.5 million. A resolution will need to approved at the August board meeting to put this issue on the ballot in November.

On a motion by Weber, seconded by Dahlgren, Shawn Young was given permission to open a firework stand in a portable firework stand. He will be required to sign a hold harmless contract, as well as provide proof of insurance for such stand. Voting Aye, Weber, Dahlgren, Evans, Schroeder, Wilcox.

On a motion by Dahlgren, seconded by Weber, the following resolution was approved:

#### **RESOLUTION NO. 368**

#### OF THE VILLAGE OF BERTRAND, NEBRASKA

WHEREAS, THE BOARD OF TRUSTEES OF THE VILLAGE OF BERTRAND, NEBRASKA DEEMS IT ADVISABLE TO ADOPT CERTAIN RULES AND REGULATIONS WITH RESPECT TO THE USE OF AND ACCESS TO THE VILLAGE YARD WASTE SITE.

NOW, THEREFORE, BE IT RESOLVED BY THE CHAIRMAN AND BOARD OF TRUSTEES TO THE VILLAGE OF BERTRAND, NEBRASKA AS FOLLOWS:

The use and access to the Village of Bertrand's yard waste site shall be governed by the following rules and regulations:

- 1. Access. Access to the yard waste site shall be controlled by gate access cards issued by the Village. Except as specifically provided otherwise herein, cards shall only be issued to the residents of the Village of Bertrand ("residents") and to non-residents who have contracted with the Village to have water service provided to their residence of business ("non-resident water users").
- 2. **Card Issuance.** One card will be issued per qualifying household and/or business. Residential card holders are prohibited from lending their card to anyone who is not a member of their immediate household. Business card holders are prohibited from lending their card to anyone who is not an owner or employee of the business and, in any event, only yard waste relating to the qualifying business shall be taken to the yard waste site. If such household or business allows such use, a fine of two hundred and fifty dollars (\$250.00) and 30 days suspension of the card will be enforced.
- 3. **Card Fees.** No fee is required for issuance of the first card per household or business. However, a five dollar (\$5.00) fee must be paid to the Village prior to issuance of replacement card in the event the initial card is lost or destroyed.
- 4. **Trees.** Non-residents who have <u>not</u> contracted with the Village to have water service provided to their residence or business may apply to the Village to dump trees and branches at the designated area(s) of the yard waste site; provided that such individuals' or businesses' access to and use of the yard waste site shall be limited to the dumping of trees and branches. Prior to receiving an access card for the limited use of dumping of trees and branches, such individuals and businesses shall also be subject to the following rules and regulations:
  - a. Commercial tree service businesses shall first pay a deposit of fifty dollars (\$50.00) to the Village. The access card shall be valid for a period of two (2) days from issuance. The deposit shall be returned if the access card is returned to the Village before it becomes invalid.
  - b. Individuals and businesses who are not commercial tree service businesses shall first pay a deposit of twenty-five (\$25.00) to the Village. The access card shall be valid for a period of twenty-four (24) hours from issuance. The deposit shall be returned if the access card is returned to the Village before it becomes invalid.
  - c. In addition to the applicable deposit required, any individuals and/or businesses (other than residents and non-resident water users) shall be subject to the following fees for the dumping of trees and/or branches:

i.	Trucks	\$20.00 per load
ii.	Pickups	\$10.00 per load
iii.	Cars	\$5.00 per load

## 5. Violations.

- Any violation of this Resolution shall subject the person and/or entity violating the Resolution to a fine of up to, but no more than, two hundred and fifty dollars (\$250.00).
- b. The Municipal Utilities Superintendent is hereby authorized to assess a fine of up to, but no more than, two hundred and fifty dollars (\$250.00) and/or suspension of use of card for 30 days per violation, in which event the fine shall be due and payable to the Village Clerk within ten (10) days after the date of issuance of the citation.

- c. The following shall subject persons and/or entities to an immediate loss of privileges of access to and use of the yard waste site, and require immediate return o the access card to the Village Clerk.
  - i. A second or further violations of this Resolution; and/or
  - ii. Failure to pay a fine on or before the due date thereof.
- d. Subsequent issuance of an access card after a second or further violation shall be at the discretion of the Village Board of Trustees or designated representative thereof.

This resolution repeals all prior resolutions in conflict herewith.

### PASSED AND APPROVED THIS 9<sup>th</sup> DAY OF MAY 2018.

On a motion by Dahlgren, seconded by Schroeder, a discussion regarding the fines for dogs running at large was tabled until the June board meeting. Voting Aye, Dahlgren, Schroeder, Evans, Weber, Wilcox.

On a motion by Dahlgren, seconded by Evans, a dog complaint regarding the dogs at 506 Mason was considered. Voting Aye, Dahlgren, Evans, Schroeder, Weber, Wilcox. The Village Clerk will inform the dog owner's by way of letter to inform them that an investigation will be completed.

A survey regarding a sales tax increase for 1.0 % to 1.5% and a bond for a swimming pool will be included in the June newsletter. Citizen will be encouraged to mail it to the Village Office or leave it in the drop box. This information will help the board to see if it would be beneficial to put it on the ballot in November.

On a motion by Dahlgren, seconded by Schroeder, the following ordinance was approved:

#### ORDINANCE NO. 669

### OF THE VILLAGE OF BERTRAND, NEBRASKA

AN ORDINANCE OF THE VILLAGE OF BERTRAND, NEBRASKA PROVIDING CERTAIN PROHIBITIONS AND RESTRICTIONS WITH RESPECT TO THE STOPPING, STANDING, AND PARKING OF VEHICLES WITHIN THE MUNICIPAL LIMITS OF THE VILLAGE OF BERTRAND, NEBRASKA; REPEALING ONLY THOSE PRIOR ORDINANCES AND RESOLUTIONS, OR PARTS THEREOF, IN CONFLICT HEREWITH; AND PROVIDING FOR THE EFFECTIVE DATE OF THIS ORDINANCE.

# NOW, THEREFORE, BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF BERTRAND, NEBRASKA AS FOLLOWS:

- 1. Except when necessary to avoid conflict with other traffic or when in compliance with law or the directions of a peace officer or traffic control device, no person shall:
  - a. Stop, stand, or park any vehicle:
    - i. On the roadway side of any vehicle stopped or parked at the edge or curb of a street;
    - ii. On a sidewalk;
    - iii. Within an intersection;
    - iv. On a crosswalk;
    - v. Between a safety zone and the adjacent curb or within thirty (30) feet of points on the curb immediately opposite the ends of a safety zone unless the Department of Transportation or the local authority indicates a different length by signs or markings;
    - vi. Alongside or opposite any street excavation or obstruction when stopping, standing, or parking would obstruct traffic;

- vii. On any railroad track; or
- viii. At any place where official signs prohibit stopping'
- b. Stand or park a vehicle, whether occupied or not, except momentarily to pick up or discharge a passenger(s):
  - i. In front of a public or private driveway;
  - ii. Within fifteen (15) feet of a fire hydrant;
  - iii. Within twenty (20) feet of an intersection;
  - iv. Within thirty (30) feet of any flashing signal, stop sign, yield sign, or other traffic control device located at the side of the roadway;
  - v. Within twenty (20) feet of the driveway entrance to any fire station and on the side of a street opposite the entrance to any fire station within seventy-five (75) feet of such entrance when properly signposted; or
  - vi. At any place where official signs prohibit standing; or
- c. Park a vehicle, whether occupied or not, except temporarily for the purpose of and while actually engaged in loading or unloading merchandise or passengers:
  - i. Within fifty (50) feet of the nearest rail of a railroad crossing; or
  - ii. Any place where official signs prohibit parking;
- 2. No person shall move a vehicle not lawfully under his or her control into any such prohibited area or away from a curb such a distance as shall be unlawful.
- 3. Any violation of this Ordinance shall be subject to the penalty provisions of Bertrand Municipal Code Section 5-501.
- 4. All prior Ordinances and Resolutions, or parts thereof, in conflict herewith, are hereby repealed.
- 5. This Ordinance shall be in full force and effect from and after its passage, approval, and publication according to law.

Lori Vinzant, Village Clerk, reported that the June newsletter will go out at the end of this month.
