## BUDGET HEARING BERTRAND NURSING HOME & ASSISTED LIVING VILLAGE OF BERTRAND, NEBRASKA

June 9, 2020

The Village Board of Trustees of the Village of Bertrand, Nebraska held the Bertrand Nursing Home & Assisted Living Budget Hearing on June 9, 2020 at 7:45 PM at the Village Hall by publishing in the Holdrege Daily Citizen on June 2, 2020 and posting at the Post Office, Countryside Market, and Village Office. The agenda was kept continuously at the office of the Village Clerk. The purpose of this hearing was to consider and take action on the Nursing Home & Assisted Living budget for the 2020-2021 fiscal year. Present were Chairman TJ Wilcox and Trustees Robert Dahlgren, Lucas Evans, Brian Schroeder, and Fred Spiegel.

The Board reviewed the Bertrand Nursing Home & Assisted Living budget as presented.

Trustee Schroeder introduced Ordinance No. 704 which adopts the budget statement to be termed the annual appropriation bill and to appropriate sums for necessary expenses and liabilities. On a motion by Spiegel, seconded by Dahlgren, the statutory rule requiring an ordinance to be fully and distinctly read on three different days was waived. Voting Aye, Spiegel, Dahlgren, Evans, Schroeder, Wilcox. The motion to suspend the rule was adopted by three-fourths of the members elected to the Board and the statutory rule was declared suspended for consideration of said Ordinance. Thereupon said Ordinance No. 704 was then read by title and Trustee Schroeder moved for its final passage, which motion was seconded by Dahlgren. Voting Aye Schroeder, Dahlgren, Evans, Spiegel, Wilcox. Said Ordinance reads as follows:

## ORDINANCE NO. 704 BERTRAND NURSING HOME & ASSISTED LIVING VILLAGE OF BERTRAND, NEBRASKA

AN ORDINANCE OF THE VILLAGE BOARD OF TRUSTEES OF THE BERTRAND NURSING HOME & ASSISTED LIVING OF THE VILLAGE OF BERTRAND, NEBRASKA, TO ADOPT THE BUDGET STATEMENT TO BE TERMED THE ANNUAL APPROPRIATION BILL; TO APPROPRIATE SUMS FOR NECESSARY EXPENSES AND LIABILITIES; TO PROVIDE FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE VILLAGE BOARD OF THE BERTRAND NURSING HOME & ASSISTED LIVING OF THE VILLAGE OF BERTRAND, NEBRASKA:

- **Section 1.** That after complying with all procedures required by law, the budget presented and set forth in the budget statement is hereby approved as the Annual Appropriation Bill for the fiscal year beginning July 1, 2020 through June 30, 2021. All sums of money contained in the budget statement are hereby appropriated for the necessary expenses and liabilities of the Bertrand Nursing Home & Assisted Living.
- **Section 2.** This ordinance shall take effect and be in full force from and after its passage, approval, and publication or posting as required by law.
