James Nelson, Village Ordinance Officer, gave the Ordinance Officer report. He stated that 5 dogs were impounded over the last month. Abandoned vehicle and weed violation letters will be sent out requiring owners to fix the nuisance. A letter was sent to the property owner of 505Marshfield. This will be the last curtesy letter that will be sent regarding the state of the un-mowed lawn. Going forward, the Village will mow the lawn once it is violation of the ordinance and the owner will be billed accordingly. It was decided that the fine would be \$100 per violation.

The progress of the pool study was discussed with no action taken. A site visit with JEO Consulting is scheduled for July 15, 2019.

On a motion by Dahlgren, seconded by Schroeder, an offer of \$18,000 to purchase the property at 906 Mason Ave on October 1, 2019 was approved. Voting Aye, Dahlgren, Schroeder, Wilcox. Voting Nay, Spiegel.

On a motion by Schroeder, seconded by Spiegel, the Board adjourned into Executive Session at 8:12 PM. Voting Aye, Schroeder, Spiegel, Dahlgren, Wilcox. On a motion by Schroeder, seconded by Spiegel, the Board came out of Executive Session at 8:24 PM.

On a motion by Schroeder, seconded by Dahlgren, a salary increase of 13% effective August 1, 2019 was given to Marcus Schwarz, Street Foreman, was approved. Voting Aye, Schroeder, Dahlgren, Spiegel, Wilcox.

On a motion by Dahlgren, seconded by Schroeder, the building permit request from Kelly Weeder to construct a 288 sq. ft. roof over the existing patio at 327 Highland was approved. Voting Aye, Dahlgren, Schroeder, Spiegel, Wilcox.

On a motion by Spiegel, seconded by Dahlgren, the building permit request from Craig Newcomb to construct a 200 sq. ft. roof over the existing patio at 103 Medina was approved. Voting Aye, Spiegel, Dahlgren, Schroeder, Wilcox.

On a motion by Schroeder, seconded by Spiegel, the purchase of four (4) tires for the road grader was approved. Voting Aye, Schroeder, Spiegel, Dahlgren, Wilcox.

On a motion by Schroeder, seconded by Dahlgren, a lease for a new copy machine for the Village Office was approved. Voting Aye, Schroeder, Dahlgren, Spiegel, Wilcox.

Brian Schroeder, Trustee, asked that the Board updates ordinances on the sexual predators in the Village.
