

Chapter 5

TRAFFIC REGULATIONS

Article 4. All-Terrain Vehicles, Scooters, and Utility Vehicles

§5-401 ALL-TERRAIN VEHICLES, SCOOTERS, GOLF CARTS, AND UTILITY VEHICLES; REGULATIONS.

(A) For the purposes of this section the following definitions shall apply unless the context clearly indicates or requires a different meaning.

ALL-TERRAIN: Any motorized off-highway vehicle which: (1) is 50 inches or less in width, (2) has a dry weight of 900 lbs. or less, (3) travels on 3 or more low pressure tires, (4) has handle bars or any other steering assembly for steering control.

UTILITY VEHICLE: Any side by side vehicle (e.g. gator, mule, or prowler)

GOLF CART: A vehicle which: (1) has at least four wheels, (2) has a maximum level ground speed of less than 20 miles per hour, (3) has a minimum passenger capacity of not more than 4 persons, (5) is designed and manufactured for operation on a golf course for sporting and recreational purposes, and (6) is not being operated within the boundaries of a golf course.

STREET OR HIGHWAY: The entire width between the boundary limits of any street, road, avenue, boulevard, or way which is publicly maintained when any part thereof is open to the use of the public for purposes of vehicular travel.

(B) An all-terrain vehicle, scooter, utility vehicle and golf cart may be operated on the streets and highways, within the corporate limits of the Village of Bertrand only if the operator and vehicle comply with the provisions of this section. Owners must show proof of insurance on all all-terrain vehicles, scooters, golf carts, and utility vehicles at the Village Office at the time of paying for registration fee \$15.00 on a yearly basis.

(C) Any person operating an all-terrain vehicle, scooter, golf cart, or utility vehicle authorized by this section shall be at least 16 years of age and shall possess a valid driver's license issued by the State of Nebraska or any other state. No person shall operate an all-terrain vehicle, scooter, golf cart, or utility vehicle on the streets or highways of the Village in violation of the Nebraska rules of the road established by the Revised Statutes of the State of Nebraska. When operating an all-terrain vehicle, scooter, golf cart, or utility vehicle, the operators and passengers must be restrained within the vehicle restraint system. If no restraint system is available, the operators and passengers must be seated at all times. Parking of an all-terrain vehicle, scooter, golf cart, or utility vehicle will not be permitted on any sidewalk. (*Ord. Nos. 246, 1/12/88; 327, 9/28/94; 536, 4/13/04; 639, 2/10/15; 674, 1/8/19*)
