On a motion by Spiegel, seconded by Schroeder, the agreement between the Village of Bertrand and JEO Consulting Group for engineering services for the new swimming pool was approved. Voting Aye, Spiegel, Schroeder, Dahlgren, Evans, Wilcox.

On a motion by Dahlgren, seconded by Schroeder, the Village Office and Village Hall will be open to the public on June 15, 2020. Voting Aye, Dahlgren, Schroeder, Evans, Spiegel, Wilcox. On a motion by Wilcox, seconded by Dahlgren, the billing procedures will return to normal on July 1, 2020. Late fees and

disconnection notices will be issued as usual. For those customers that are overdue with current payments due to the pandemic, they will have an option to set up a payment plan for up to six months to get current on bills. Voting Aye, Wilcox, Dahlgren, Evans, Schroeder, Spiegel.

On a motion by Dahlgren, seconded by Schroeder, the discussion regarding the State of Nebraska Tax Credit for donation made towards the new swimming pool will be tabled until more information can be provided. Voting Aye, Dahlgren, Schroeder, Evans, Spiegel, Wilcox.

Brad Slaughter, Piper Jaffray Representative via phone, went over the options for the bond issuance for the new swimming pool. On a motion by Dahlgren, seconded by Schroeder, the Board approved to have issued \$2.5 million in revenue bonds for the swimming pool project. This will be finalized at the next meeting. Voting Aye, Dahlgren, Schroeder, Spiegel, Wilcox.

James Nelson, Village Ordinance Officer, gave his report. There are a few properties that will need lawn nuisance letters sent in the next couple of days. He will review properties and structures for nuisance abatement or rescinding for the next meeting. He informed the Board that the restriction for abandoned vehicle tickets was only for the months of April and May. On a motion by Dahlgren, seconded by Schroeder, it was approved to resume issuing abandoned vehicle tickets on June 15, 2020. Voting Aye, Dahlgren, Schroeder, Evans, Spiegel, Wilcox.

Matt Gregg, Village Superintendent, gave his report. He informed the Board that one well is shut down due to malfunction. He is working to get it fixed, but Board approval will probably be needed because the amount of the repair will go over his allotted amount. He will be having Popple Construction do the cement work on the streets that need to be repaired. He also informed the Board of an issue with Bertrand Community Schools. During the last winter, there was damage done to a resident's property due to snow being pushed from the school's parking lot. Gregg will notify the school district that no snow is allowed to be on any property except their own.

Lori Vinzant, Village Clerk, gave her report. The terms of two Board members will be ending at the end of the year. If the members would like to re-run, they have until July 15, 2020 to file. Any non-members have until August 15, 2020 to file.
