Hueftle presented the Board with the 2017 Nuisance Abatement Program properties that have been cleared of nuisances and recommended that these properties be rescinded. On a motion by Dahlgren, seconded by Schroeder, the Board approved Resolutions 2017-349-1014, 1009, 1005, 1070 and 1056, which states that these properties shave been rescinded. Voting Aye, Dahlgren, Schroeder, Wilcox, Weber, Evans. Hueftle presented the Board with the 2017 properties that needed to be abated. On a motion by Dahlgren, seconded by Weber, the Board approved the abatement of properties 2017-BERT-1027, 1041, 1051, 1054, and 1056. Voting Aye, Dahlgren, Weber, Evans, Schroeder, Wilcox. On a motion by Weber, seconded by Dahlgren, the Board approved the postponement request from one property owner for an extension until November 1, 2017. Voting Aye, Weber, Dahlgren, Evans, Schroeder, Wilcox.

Miller & Associates representative Brian Langenberg presented the Lot Split; North 2 feet of Lot 4, Block 5, Second Addition. On a motion by Dahlgren, seconded by Schroeder, the Board approved the split. Voting Aye, Dahlgren, Schroeder, Weber, Evans. Abstaining, Wilcox.

Van Fastenau, Chairman of the Bertrand Rural Fire Protection District informed the Board that their Board has approved the amount of \$243,141.00 that will be transferred to the new Fire District when all parties involved have approved. A Special Meeting will be held between the Bertrand Board of Trustees and the Rural Fire Protection District in the near future.

On a motion by Dahlgren, seconded by Weber, the Board voted to table any action on Ordinance No. 11-101; Definitions/Accessory Buildings until the August meeting. Trustee Dahlgren will

contact the Village Attorney and have him write up a new ordinance that the Board will examine. The ordinance that is in place now is very outdated and needs to be brought up to date. Voting Aye, Dahlgren, Weber, Evans, Schroeder, Wilcox.

On a motion by Dahlgren, seconded by Weber, the Board voted to change the crop for the 2018 year on the tract of land, located in the SW ¼ of Section 6, T.6N., R. 20W of the 6<sup>th</sup> P.M., Phelps County. Alfalfa has been planted here for several years. A letter of termination will be sent to the present tenant. Voting Aye, Dahlgren, Weber, Wilcox, Evans, Schroeder.

On a motion by Dahlgren, seconded by Weber, the Board voted to table any action on Ordinances No. 7-301, 7-303 and 7-304; which state Fireworks, Fireworks Sale and Fireworks Use. This will give the Board time to accumulate information on what surrounding towns do. Voting Aye, Dahlgren, Weber, Wilcox, Evans, Schroeder.

On a motion by Weber, seconded by Dahlgren, the Board approved Crys Johnsen's application to construct a dinning room/kitchen addition at 910 Kane Street with the stipulation that 36" footings were used and that she came in and signed her application. Voting Aye, Weber, Dahlgren, Evans, Schroeder, Wilcox.

On a motion by Evans, seconded by Schroeder, Larry White's application to construct a privacy fence at 705 Melbourne was approved. Voting Aye, Evans, Schroeder, Weber, Dahlgren. Abstaining, Wilcox.

On a motion by Schroeder, seconded by Wilcox, Lucas Evans application to construct a 40x60 work shop at 507 Marshall was approved. Voting Aye, Schroeder, Wilcox, Dahlgren, Weber. Abstaining, Evans.

On a motion by Evans, seconded by Schroeder, Mandy Ladwig's application to construct a privacy fence at 307 Union Street was approved. Voting Aye, Evans, Schroeder, Wilcox, Weber, Dahlgren.

Village Superintendent Matt Gregg informed the Board that there would be a meeting in July 19, 2017 from 6:30 PM – 7:30 PM at the Blue Moose Bar & Grill with Phelps County Development Corporation. This meeting is about developing a countywide strategy for development of housing. Gregg also told the Board that the pool will be closing on August 6<sup>th</sup> and said that they have had a very good year.

Trustees Jerold Weber thanked the Village employees for all their time and effort with the new playground equipment at the park. Weber said the only thing left was to build a ramp.

Village Clerk Carol Johnston asked the Board if the Village Office could close from 10:30 AM to 12:30 PM on Friday July 14<sup>th</sup> so the Village employees could attend the services for Dan McCraken. The Board gave their permission. Johnston also presented the Board with a list of addresses that need to have trees trimmed that are hanging below the 12' requirement that is stated in Ordinance No. 8-508 and dead trees that need to be removed that is stated in Ordinance No. 8-509. The Board approved the sending of letters to those residents who are not in compliance with these ordinances.

On a motion by Dahlgren, seconded by Schroeder, the meeting adjourned at 9:04 PM. Voting Aye, Dahlgren, Schroeder, Evans, Weber, Wilcox.
