October 8, 2024

The Village Board of Trustees of the Village of Bertrand, Nebraska held a Regular Meeting on October 8, 2024, at the Village Hall by publishing in the Holdrege Daily Citizen on October 1, 2024, and posting at the First State Bank, Post Office, and Village Office. The agenda for said meeting was kept continuously at the office of the Village Clerk. Present were Chairman TJ Wilcox, and Trustees Robert Dahlgren, Jason McNierney, and Brian Schroeder. Trustee Lucas Evans was absent.

Section 6. In the event the fees for water, sewer, and/or garbage are not paid on or before the 15th day of the month, the utility customer shall be subject to a late fee of \$20.00. When a billing is made by the Village of Bertrand for supplying water or furnishing equipment required by this title to any premises becomes delinquent in whole or in part on or after the 22nd day of the month, or when the water service to any premises is being used or maintained contrary to any of the other requirements of this title, the Water/Sewer Superintendent may order the water service to such premises discontinued until such billing be pair or until such contrary use of the maintenance cease.

Section 7. All prior ordinances and resolutions, or parts thereof, are hereby repealed to the extent that they are contrary and inconsistent with this Ordinance.

Section 8. This Ordinance shall be in effect and in full force from and after its passage, approval, and publication or posting as required by law.

James Nelson, Ordinance Officer, gave his report to the Board. He has still been unsuccessful to locate a correct book of citations to be used within the Village limits. He also stated that 4 Board Members are in nuisance violations and those need to be addressed. He is currently attending a continuing education class.

Matt Gregg, Utilities Superintendent, gave his report to the Board. He attended the Rural Water Conference and the Mosquito/Vector conference. He informed the Board of the progress of the Sewer Lagoon project. It is very behind schedule. There are questions regarding the lining of the new lagoon. He also stated that he will be scheduling the hail damage repair of the Village's properties.

Lori Vinzant, Village Clerk/Treasurer, gave her report to the Board. She informed the Board that the annual audit will be held on October 30, 2024. She also informed the Board that she will be meeting with the Phelps County Development Corporation in the next week to discuss the possible DF Fuel aviation fuel plant project.
